

ASWfor Foundation Donation Policy and Terms

- The website is operated by Fundacja ASW*for* Foundation, based in Bielawa, ul. Warszawska 202, 05-520 Konstancin-Jeziorna, identified by the following numbers: NIP (Tax ID): 1231544290, REGON: 526955750, KRS: 0001068577
- 2. The website allows financial support for the Foundation's statutory activities and special purpose funds.
- 3. These terms aim to define the conditions for making online donations via the donation form available on the websites: <u>aswfor.org</u>
- 4. One-time online payments are processed by the payment operator: tPay -payment system of Krajowy Integrator Płatności S.A. based in Poznań, plac Andersa 3, 17th floor, 61-894 Poznań, entered into the register of entrepreneurs kept by the District Court Poznań – Nowe Miasto i Wilda in Poznań, 8th Commercial Division of the National Court Register under number 0000412357, NIP 7773061579, REGON 300878437.
- 5. Donations can be made by any adult individual, legal entity, or organizational unit. These individuals or entities will hereinafter be referred to as "Donors."
- 6. Donations made through the website are processed continuously.
- 7. To make a one-time donation, after completing the form available on the website, the Donor will be redirected to the payment operator's site.
- 8. For online payments, the Donor can use electronic transfers, traditional bank transfers and card payments.
- 9. Every Donor who completes the form and proceeds to the payment service consents to the processing of their data for marketing purposes, in accordance with the provisions of this Policy.
- 10. By providing information in the form, the Donor accepts this Policy and consents to the processing of personal data by the Foundation in accordance with the conditions outlined in this Policy and for the purposes specified herein.
- 11. The data controller is Fundacja ASW*for* Foundation, as identified above.
- 12. Donors have the right to access their data, request corrections, demand deletion, limit the processing, object to the processing of their personal data, and file a complaint with the supervisory authority if the data is processed unlawfully.
- 13. Data will be processed for the purpose of entering into and performing the donation agreement with the data controller, as well as making any necessary

settlements related to it (where required), and to fulfill the Foundation's statutory activities. Data may also be processed for marketing purposes.

- 14. Data may be processed in a fully automated manner, including profiling.
- 15. Providing personal data is voluntary; however, failure to provide the data will prevent the conclusion of the donation agreement.
- 16. Where data is processed based on separate consent, the Donor has the right to withdraw consent at any time. Such withdrawal will not affect the legality of the processing conducted prior to the withdrawal.
- 17. Personal data will generally be processed for the period necessary to meet the statute of limitations for claims and obligations arising from the agreement entered into with the data controller.
- 18. In justified cases, the Donor may submit a complaint and request a refund of the donation. Complaints should be submitted via email to: <u>aswforfoundation@aswarsaw.org</u>, with the subject line "complaint" and including the reason and detailed transaction information. Each complaint will be reviewed individually by the Foundation within 14 days from the date of receipt.
- 19. The Foundation reserves the right to amend this Policy at any time.
- 20. Matters not regulated by this Policy are governed by applicable law.
